1. Apologies for absence:

Apologies were accepted from Cllr Johnson

2. Declarations of members' interests in respect of items on this agenda.

No declarations of interest were made.

3. Review and approval of the Minutes of the last finance committee meeting held on 12th December 2016.

The minutes were approved and signed as a true record.

Everything on here from ESCC is that they are doing less and the parish council are expected to do more.

View is that we need to plan for this expenditure.

9% was our increase last year, and we propose a 9% increase again this £8,340. Whuich would equate to an increase of 39 p per month per Buxted Parish Council household.

Would like to budget £3500 on consultations

£700 office costs – cosnider cimputer expnediure

Increase of £2,000 Highways

£500 increase for public meeting expenses

£11,700 increase in expenditure, £2000 in decreases, £1000 on that is maintenance where spending less than previous, £1000 where we were conservative on pension costs.

Consideration given to our current EMR and balances.

Meeting in May 2018 to consider our reserve position. Clerk to produce end of year figures for consdieraiton.

Aware that other parish councils are creating a Highways budget to take on those expenses, and maybe this is something that we need to consider in the future. Consideration to whats the most important when look at EMR.

The finance committee resolved to recommend to full parish council a precept request of £101,011 which is an increase of 9%.
